Get ready to VOTE!

PRIMARY AND LOCAL ELECTIONS ARE ON AUG. 18

We are only a few weeks away from the primary and local elections on Aug. 18. The League of Women Voters wants to make sure that you are ready to vote. Here's what you need to do and how the LWV can help.

Everyone who votes on Aug. 18 must be registered by now. If you missed that deadline, be sure you register so that you can vote in the general election in November. If you are registered, you may still request a vote by mail ballot, but do it immediately. The deadline is Aug. 3. Ballots have gone out already. The turnaround time for mine in the mail was a week, so don't dawdle! Early voting is

Aug. 7-15. You may check your voting status through the League's VOTE411.org site or the Supervisor of Elections Office at votealachua.gov. Make sure your family and friends know all this, too.

Next, educate yourself on the candidates and their positions. Meet them in person, if you can. It is always illuminating to talk with the candidates one on one, and in Alachua County, most of them are accessible. If you can't encounter them in person, access videos of the forums at the Alachua Democratic Party web site at tinyurl.com/iguana2534 (scroll to the bottom of the page for links to the forum videos). The candidates all gave thoughtful answers to the League's questions. Last, but certainly not least, go to VOTE411.org.

There, you will find candidate profiles and answers to more LWV questions.

You have used the LWV resources and made your decisions. Now you are ready to vote, but as an engaged citizen, you are not ready for the election. Your next step is one that I, as president of the local LWV chapter, must skip. Once you have picked your candidates, work for them. Support them with your time and your money. Give house parties and introduce them to your neighbors. Talk politics with everyone you know. Put up yard signs. Try to choose candidates who favor the interest of the many over the interest of the few, even if you are one of the few. That's what democracy is about.

VICTORY:

Federal appeals court decisively rejects Florida's 'Stop WOKE Act'

by Foundation for Individual Rights and Expression (FIRE)

Following a First Amendment lawsuit filed by the Foundation for Individual Rights and Expression, a federal appeals court ruled today that Florida's "Stop WOKE Act" — a broad ban on what faculty at public universities may discuss in the classroom — violates the First Amendment rights of Florida university faculty and students. The ruling affirms a previous court decision that blocked the legislation from taking effect.

"Though the government has plenty of ways to promote its own viewpoint, puppeteering every university professor in the state is not one of them," wrote Judge Britt C. Grant of the U.S. Court of

Longtime Gainesville activist to receive Susan B. Anthony Award at Women's Equality Day luncheon

The Friends of Susan B. Anthony is pleased to announce that Pam Smith will receive the Susan B. Anthony Award at their annual luncheon on Saturday, Aug. 22. Pam has a long history of activism for many different causes: women's rights and health care, anti-nuclear protests, and environmental issues. She helped to organize the Southeastern Women's Health Conference here in 1976, where she co-conducted one of the first workshops specifically on child incest. Recently, she was instrumental in founding Gainesville Women for Democracy, which has over 3000 members, and has been a prime mover in the No Kings protests. This luncheon began as an informal birthday party for Susan B. Anthony over forty years ago, and is now held in conjunction with the anniversary of the passage of the 19th Amendment giving women the right to vote. Each year a local woman is recognized who exemplifies the spirit of Susan B. Anthony.

The luncheon theme for 2026 is: "Our Vote is Our Voice: Women's Political Power." The featured speaker will be Dr. Teresa Cornacchione, Civic Engagement Coordinator from the Graham Center.

As we move through the normality of the days of our lives, we each have our own windows on the world we live in. There are the ones we have created for ourselves (house, job, family, car; if we are lucky), and the stuff going on in the remote world that has no direct impact on our lives except how much we choose to be aware of it. Many of us are the type of people who crave awareness of what's going on, and this impacts us because we are bothered by what we are seeing. It affects us, our sense of responsibility; this is OUR government doing all these horrible things. What we are seeing now, in an avalanche of disturbing developments created in the span of one administration, really challenges us to cope, let alone focus on doing our part to find our way out of it.

We see wars with no end game. Social safety nets being shredded. Immigrants being rounded up. On and on and on. All just everyday news. These have become our new normal. And then there is the normalization of having a person like Trump as commander in chief with no guardrails being put on him from Congress, the courts, or the media (with few exceptions). That man-child even managed to taint World Cup with his improper meddling!

There is so much to be gloomy about if we are only looking out at all the negative things going on that the lived experience of our lives can become overshadowed by it. Resistance is both needed, and therapeutic. I truly love World Cup. It felt great that our World Cup crowd at Cypress & Grove did some strong booing at that clown's picture every time it was on the screen at the Final Sunday. Some folks were for Argentina, some for Spain, but we all were together on that. The true experience of World Cup is sharing the joy of being a citizen of this planet, and seeing folks from the globe come together around that construct is a wondrous thing, even while being aware of the downward track things seem to be going in the world. So many great human stories and drama.

A couple weeks ago I was in Chicago for the semi-annual Labor Notes Conference; 4,500 labor activists from around the country and world come together every two years for four days. (Labor Notes writers did a good overview, which is in the Eds' Picks on page 18). I had a good recharge of my positive vibes there as well. One speaker on Friday night really struck a chord with me. Paul Osadebe is with the Federal Unionist Network, and he spoke of how various federal workers came together at a workshop at Labor Notes in 2022 and that was the catalyst for their organization. In 2024 at Labor Notes they met again, and with Trump's re-election on the horizon, they knew their organization faced real challenges ahead, and that meant they organized, strategized, and were ready to resist when Trump and DOGE started in on them in 2025. That spunky little magazine and their semi-annual conferences had a direct effect on thousands of lives as they resisted the firings, layoffs, and shutdowns!

So we all do what we can. Individually, we can vary our information sources, the windows we look out of; that can surely help. Celebrating and participating in what we have in our community and being more positive is a form of resistance, too. The Weekly Show with Jon Stewart:

Mayor Zohran Mamdani on socialism, politics & NYC

This is an excerpt from a July 22 interview with Jon Stewart of the Weekly Show interviewing New York City Mayor Zohran Mamdani.

JON STEWART: So in some respects, is it about the priorities you have about the quality of life for those [people], even if they don't make [a lot of money]? Because universal pre-K or universal childcare — those kinds of things, you know, de Blasio might have brought that up ... I think that the caricature of democratic socialism is that ... it's a completely different ideology than those that we have seen, or is it, perhaps, just a different nomenclature?

ZOHRAN MAMDANI: I think part of it is that words have lost their meaning over time.

JON STEWART: There we go. This is where I'm getting to is, is it really about the label?

ZOHRAN MAMDANI: I think if you go back to some of the Democrats that we most admire — FDR, LaGuardia — you will see a lot of democratic socialist principles in their vision. And if you think about a lot of what we've come to accept as just the facts of life across our country, a lot of it is still driven by democratic socialist principles. Now, if today, you and I were to introduce the idea of a building that lends out books for free, we would be slandered in the same way that so many new ideas are slandered today, and yet, that's the library, and the same thing with the fire department, and the same thing with public schools.

And it's to say that a lot of politics has been a debate about who deserves what, and I would prefer a politics that debates how we

can deliver that to everyone. And to deliver it at a standard that is so good, that no matter how much money you have in your pocket, you opt for that. And I think at its best, the New York subway is an illustration, where no matter how much money you have in your pocket, you understand that if you want to get from point A to point B, the best way is to get on that train.

JON STEWART: That's for sure. So to that end, was there ever a consideration for you, because of the priorities that you have, why take on the label of Democratic Socialist, knowing that it comes with a lot of other baggage that may not be helpful to you in your pursuit of what are — what was it about what they were saying that drew you — as opposed to running as the things that you're suggesting to me, if you ran on these as a Democrat — it's not I wouldn't say like, "What? What the heck?" It sounds very much in line with that. It sounds like what you're doing differently is you're being competent, or ruthlessly pursuing those goals and chipping away at them. So why take that on?

ZOHRAN MAMDANI: You know, I want to be honest with people about what it is that I actually believe in. And I also think what we've seen over many decades is a fear-mongering in our politics where anything that we disagree with, or anything that portends significant change is described as if it is socialist, at times as if it is communist. And the intent of that is to end the conversation there and then. And it especially happens when you're talking about something that would disproportionately benefit working people.

I think it's important because we keep speaking about some of the inequities and inequalities that we see in our city as if they are bugs in a system as opposed to features in them. If we truly want to reckon with one in four New Yorkers being in poverty, we have to also ask ourselves about if it's important to change the framework with which what we determine success to be.

Also, being a Muslim Democratic Socialist, I thought it would be pretty straightforward.

‘We welcome the other here’

On July 13, ICE agents shot and killed 26-year-old Johan Sebastián Guerrero in Biddeford, Maine. Below is an excerpt from a speech by Maine Speaker of the House Ryan Fecteau.

RYAN FECTEAU: For me, I put this moment into context by my own experience living and growing up right here in the City of Biddeford. I think it’s important that we capture, just for a second, what this community is. This is a community that was built by immigrants. Those mills, those mills that stand in the center of our city were built by immigrants. My grandparents came here in 1964 with my dad from Quebec to work in those textile mills with other immigrants. We are a community of immigrants. We are a community of immigrants. We have always been a community of immigrants. We will always be a community of immigrants no matter what we face, no matter what they try to do. We will continue to be a community that was founded by, built by/for immigrants.

... Americans who called this place home for many centuries, for many decades, or the Albanians who also were here. And one of the things that I always find so inspiring is if you go to Woodlawn Cemetery here in Biddeford, there’s a part of the cemetery where you’ll distinctly know the gravestones because they’re all turned towards Albania. Biddeford had a large Albanian population when those textile mills were roaring, and we also were home to the first mosque in the United States.

We were French-Catholic; we were Albanian-Muslim. We are Albanian-Muslim today; we are French-Catholic today. We are many things today because we have always welcomed the other. We have always been welcoming to our neighbors and we will not stop. We will not stop.

This is my message to the federal government. Get out of our state. Get out of our city. We welcome the other here. We welcome immigrants here. We are a welcoming state. We will not change. We will not change for Donald Trump or anyone else. This is a place that welcomes our neighbors.

‘Imagine all the better things that could have been done’: Trump has blown \$37.5 billion on Iran War

While economists have warned for months that the true cost of President Donald Trump’s illegal war on Iran could be trillions of dollars, U.S. Defense Secretary Pete Hegseth estimated that it’s currently about \$37.5 billion.

That figure came from a line of questioning by U.S. Sen. Dick Durbin (D-Ill.), as Hegseth appeared before the Senate Appropriations Committee to support Trump’s June supplemental funding request, which includes tens of billions for the Pentagon.

Hegseth told Durbin that the \$37.5 billion estimate includes what’s been spent so far, plus some projected spending through the end of the fiscal year in September — an exchange quickly met with fury by various critics, many of whom pointed out the range of ways that money could have been better spent by an administration allegedly dedicated to combating “waste, fraud, and abuse.”

“Imagine all the better things that could have been done with \$37.5 billion,” Jonathan Cohn, political director for the group Progressive Mass, wrote on Bluesky.

Noting that the Strait of Hormuz “is still closed,” progressive writer Alex Cole similarly said, “Imagine what \$37.5 billion could’ve done for veterans, schools, or healthcare.”

Congressman James Walkinshaw (D-Va.) specifically noted: “That could cover a full school year of free lunches for 30 million children. Or a full year of childcare for nearly 2 million kids.”

“Trump finds money for war while families get excuses,” he added, as working people struggle with rising costs of housing, groceries, and gasoline—the price of which has soared due to Iran restricting strait traffic over U.S. attacks.

The liberal political group American Bridge 21st Century highlighted how Trump and congressional Republicans have attacked programs for working families while giving more tax cuts to billionaires and waging war on Iran.

“THIS from the administration that said there was no money for food assistance, Medicaid, and healthcare tax credits,” the organization said.

Since Trump joined with Israel to start bombing Iran on Feb. 28, most congressional Democrats, legal experts, and other critics have argued that the war—for which the president never secured support from Congress—is not only foolish but also unlawful under both international and U.S. law.

Citing Trump’s attempts to evade limits of the War Powers Act of 1973, Congressman John Larson (D-Conn.) said Monday that he is preparing legal action against the administration and a new bill to cut off funding for the war on Iran, which has killed over 3,000 people according to the Iranian government.

Previous war cost estimates from the U.S. Department of Defense have been met with scrutiny. After Pentagon comptroller Jules “Jay” Hurst offered the \$25 billion figure in April, Stephen Semler, a senior fellow at the Center for International Policy, estimated that the government spent at least \$71.8 billion during the first two months of the war, or around \$1.2 billion per day.

As for the U.S. death toll, at least 17 service members have been killed and many

more wounded. The New York Times revealed Monday that the Pentagon hid dozens of American military injuries from Iranian strikes on bases in Jordan last week.

Two Iranian-Americans, a U.S. veteran, and a nurse disrupted Hegseth's Tuesday appearance before the Senate, according to CodePink. In addition to that anti-war group, the protesters were from the National Iranian American Council (NIAC) and Vets About Face DMV.

"Pete Hegseth and this administration will be remembered for the killing of innocent civilians and children. They have

protected neither the American people nor our security, only the interests that have lined their pockets," said Bella of NIAC, who joined the protest.

"While Americans struggle to afford their lives, this government always finds billions to bomb our families in Iran, Palestine, Lebanon, and elsewhere," Bella added.

"This is a repugnant betrayal of humanity. It is illegal, and the American people will hold them accountable."

Make Social Security secure: Momentum builds to ‘scrap the wage cap’

At the invitation of Vermont Sen. Bernie Sanders, Social Security Works President Nancy Altman testified in late June before the Senate subcommittee on Social Security, of which Sanders is a ranking member.

Nancy told the Senate that the projected 2032 Social Security shortfall, which is estimated to be 23-25 percent, is the result of Trump administration policies.

Several bills have been submitted to Congress to eliminate the FICA wage cap. We'll see what happens knowing full well that what is said today doesn't mean it will be signed into law tomorrow. We have to wait and observe and keep speaking up. Below is what Nancy Altman said to subcommittee members:

Social Security was enacted to provide basic economic security when wages are lost in the event of disability, death or old age. Therefore, the first question we should ask is, what level of benefits should Social Security provide?

Today's benefits are low by virtually any measure. Cutting those already inadequate benefits will deepen the nation's looming retirement income crisis. And cutting benefits will hurt the economy. By the same token, expanding Social Security's modest benefits will increase economic security and strengthen the economy.

That leaves the question of how the expanded benefits are financed and the shortfall eliminated. It is imperative to recognize that, after Congress enacted the Social Security Amendments of 1983, the subsequent Trustees' Report projected that Social Security was funded for the full 75-year valuation period and beyond, which ran through 2058.

But the actuaries didn't anticipate the huge income and wealth inequality that followed the 1983 amendments. Recent decades have seen a dramatic increase in the share of income going to those at the top. That inequality has cost Social Security more than \$1.5 trillion since 1983. That is \$1.5 trillion that should have gone to Social Security but instead stayed in the pockets of the wealthiest among us.

This year's trustees report has projected that Congress must act by 2032. That is

one year sooner than last year's report projected. The earlier date is the result of Trump administration policies, specifically, its first reconciliation bill giving tax breaks to the wealthiest and its hostility to immigrants, who every year contribute tens of billions more dollars to Social Security than they draw out. Moreover, the administration's tariffs and its war of choice against Iran will undoubtedly increase unemployment and inflation, harming Social Security even more.

The 2032 date is best understood as an action-forcing event. The question isn't whether Congress will act, but rather what it does and whether that action will come transparently, through regular order, or through an undemocratic closed-door, fast-tracked process.

Two pieces of good news: First, there is no question we can afford an expanded Social Security, whose total cost at the end of the century is less than 7 percent of GDP.

The second piece of good news is that, as polarized as the American people are, we are united about Social Security. Poll after poll reports that from MAGA Republicans

to progressive Democrats, the American people overwhelmingly reject benefit cuts even if paired with some revenue increases. To be clear, raising the retirement age and means-testing benefits are benefit cuts. The American people strongly and overwhelmingly prefer more revenue, ideally paid by the wealthiest Americans. They also strongly support benefit increases. This is also the best policy.

What should not happen is the establishment of a commission whose recommendations are privileged and fast-tracked. That would be unprecedented and a deep disservice to the American people. Such a commission's only purpose would be to insulate and protect members of Congress from facing political accountability. Instead, all Social Security legislation should go through regular order, as it always has. Thank you. 🐢

What is capitalism?

What is capitalism?

A seemingly simple question, but it is a question that has puzzled radicals and conservatives, academics and working people alike, for centuries now. Adam Smith, the Scottish Enlightenment thinker who provided much of the intellectual foundation for modern capitalism, saw its defining force as one of economic rationalization, efficiency, and the blooming of human potential and wealth through increased production and free trade.

From his perspective in the eighteenth century, maybe he was right. But from our vantage point in the twenty-first century, when big business has overwhelmed and overtaken democratic processes, driven imperialist adventurism from Venezuela to the Strait of Hormuz and beyond, and fueled racial, ethnic, and religious bigotry, that rationality is hard to see.

Advocates for capitalism like Margaret Thatcher have argued that there is no alternative, that capitalism is natural, an outgrowth of intrinsic human behaviors. But is that true?

In order to answer the question, we must understand what capitalism actually is, and more importantly, how it works. From an understanding of its internal processes, its logical and illogical developments, and the relationships it constructs between those who have and those who have not, we see why the liberation and efficiency promised by people like Smith, Thatcher, and the current American administration curdles over and over again into exploitation, criminality, and the violent repression of dissenting views.

For Karl Marx, the great intellectual forebear of the socialist movements of the nineteenth, twentieth, and twenty-first centuries, the reason for this was obvious. For him, capitalism was not a theoretical conception of human behavior. It was a social structure built by human beings, a historical product of choices made across centuries, and ultimately a source of immense social, cultural, and political power, one reserved only for those with the resources to own and exploit the immense productive powers of capital and labor alike.

From basic first principles, Marx and others who followed him sought to dissect capitalism from its origins to its noxious end-points. They saw in capitalism the division of society itself into those who possess property and those who possess nothing but their own labor.

They also realized that capitalism was internally contradictory. In order to make use of their immense holdings of capital – the factories and machines that gave industrial capitalism its astounding productivity – capitalists needed more and more workers, brought together to share the same labor, the same exploitation, and the same resentments.

As the working classes grew, they became increasingly radicalized by the realization that while the workers themselves lived on the knife's edge, paid nothing more than the wages needed to stay alive, and sometimes not even that, their labor was the key to the profits that the capitalist class used to build opulent mansions, to expand production around the world, and to ensure that the political class

was wrapped around their finger. Through organization and radicalization, the workers developed their own forms of resistance and power, a force that could challenge capitalists' claims to economic and social dominance. As Marx argued, capitalism had created its own gravediggers.

This analysis has undergirded revolutionary movements, working-class radicals, and oppressed peoples who saw in the vision of an alternative genuine liberation and a future for humanity defined by freedom and equality.

This documentary examines the long struggle for freedom in Palestine, told through the voices of Palestinians. It serves as a reminder that imperialism, racism, and capitalism are interwoven, and that in order to defeat one, we must defeat them all.

Things are dark right now. The world order promised by Trump and his minions is one of unending hatred, exploitation, and bloodshed. Their vision is apocalyptic. But they are not all-powerful. Working together, we can reject the horrors they promise. Working together, a better future is possible. ✨

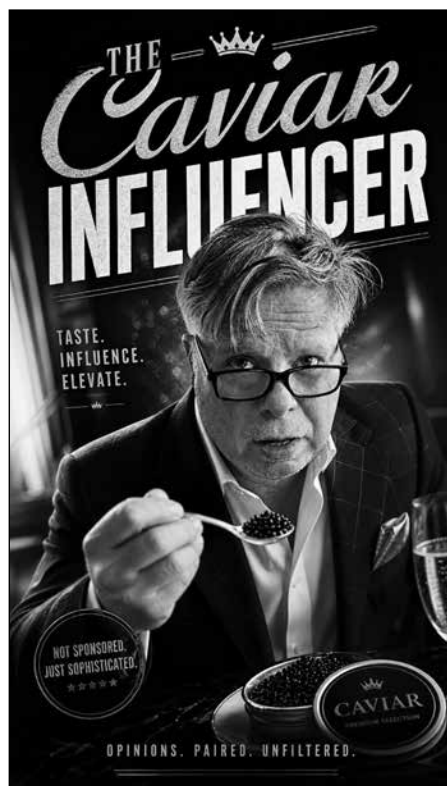

Performance artist Tom Miller's wildest reinvention yet?

The Gainesville icon is chasing the world of caviar

For most people, the phrase “career change” means updating a résumé.

For Tom Miller, it means spending months studying the history of sturgeon, contacting caviar producers across multiple continents, enrolling in one of the

world’s most respected caviar education programs, and announcing, with complete sincerity, that his next artistic obsession involves tiny black pearls served on a mother-of-pearl spoon.

If history is any indication, nobody should be surprised.

The longtime Gainesville performance artist, filmmaker, playwright, actor, humorist, and professional curiosity chaser has built an entire career around asking, “What happens if I dive completely into something unusual?”

His answer has produced decades of experimental performances, public happenings, films, paintings, writing, and theatrical work that have earned him a reputation as one of Florida’s most delightfully unpredictable artists.

His newest canvas?

Caviar.

Not as a luxury status symbol.

As history.

As craftsmanship.

As storytelling.

“I’ve always believed food tells stories,” Miller says. “Every culture has dishes that represent history, geography, survival, celebration, and identity. Caviar happens to be one of the oldest luxury foods on Earth, but most people know almost

nothing about it beyond the stereotypes.”

Instead of treating caviar as something reserved for billionaires and celebrities, Miller wants to demystify it.

His plan is refreshingly transparent.

He’s starting at the beginning.

Rather than pretending to be an expert, Miller intends to document the transformation from enthusiastic beginner to genuine authority, inviting viewers along for every success, mistake, surprising discovery, and expensive lesson.

That journey has already begun.

Miller is currently enrolled in the AP-WASI Caviar Professional certification program, an intensive educational course widely respected within the luxury food and hospitality world. The curriculum dives deeply into sturgeon species, production methods, sustainability, harvesting, grading, service, storage, tasting methodology, regional traditions, and the science behind one of the world’s most misunderstood delicacies.

“It’s basically caviar college,” Miller laughs.

If everything goes according to plan, he expects to complete the certification over the next couple of months, adding a rare professional credential to an already unconventional résumé.

But he’s not waiting until graduation to begin sharing what he’s learning.

Over the past several weeks, Miller has been reaching out to caviar producers, importers, distributors, aquaculture farms, and luxury food companies around the globe, introducing himself, asking questions, and building relationships within an industry that values knowledge as much as exclusivity.

Those conversations have already led to his first official partnership.

Miller recently became an affiliate ambassador for Regalis Fine Foods, one of America’s best-known purveyors of luxury ingredients, including premium caviar, truffles, wild mushrooms, Japanese seafood, and other exceptional culinary products.

“It’s exciting because every expert starts somewhere,” Miller says. “I’m not trying to skip to the end. I want people to watch the journey happen in real time.”



That philosophy is expected to become the defining feature of his newest online project.

By design, Miller's first caviar review premiered on National Caviar Day, Saturday, July 18. The date wasn't chosen by accident. He wanted the launch to serve as the official beginning of what he hopes becomes one of YouTube's most entertaining and informative journeys into the world of caviar.

The debut video will introduce viewers to the channel's mission while kicking off a long-running series of tastings, interviews, educational features, culinary adventures, industry visits, historical deep dives, blind comparisons, and conversations with the people responsible for producing some of the world's finest roe.

Unlike many influencer channels that chase quick clicks, Miller's goal is to create something with staying power.

Think less "Look how expensive this is," and more "Let's understand why this exists."

He hopes viewers who discover the channel now will be able to say they were there from the very beginning.

His ambition is certainly not modest.

Miller hopes to grow the channel from zero subscribers to one million, while evolving from curious newcomer into one of the internet's most trusted and entertaining voices on caviar.

It's the kind of improbable challenge that somehow sounds perfectly reasonable coming from a man whose artistic career has consistently refused to fit into neat categories.

"Like, Share, and Subscribe."

He laughs after saying it, admitting it feels strangely satisfying to finally utter one of the internet's most recognizable phrases.

"I've always wanted to officially say those words."

If readers enjoy watching someone pursue mastery in real time, Miller hopes they'll become part of the story from day one by subscribing to the channel, sharing the videos with fellow food lovers, and following along as he navigates the fascinating world of caviar, one tin at a time.

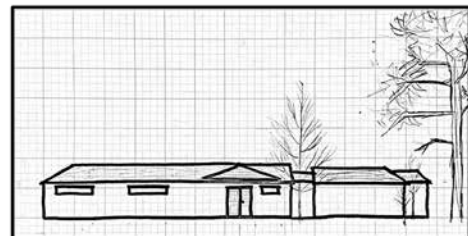

A secret fan donates nearly \$1 million to help save South Florida's rare pine rocklands

One of the rarest forests in the world, found only in South Florida and the Caribbean, and home to a host of endangered plants and animals, is getting a boost from an anonymous patron. The unnamed donor gave \$925,000 to a coalition of environmental groups to preserve and manage pine rockland, which the groups turned over to Miami-Dade County's Environmentally Endangered Lands program. Only 2 percent of the county's pineland remains, and despite years of efforts to buy and preserve land, some plots have languished on an acquisition list for decades.

DSA candidates in New York, Pennsylvania, and Colorado have had recent electoral successes. And in Florida, Democratic Socialist Oliver Larkin, a 34-year-old former union organizer, is running in the Aug. 18 Democratic primary against Jared Moskowitz in South Florida's newly configured Congressional District 25, which now

runs along the southeast coast from Delray Beach to Miami Beach. The only DSA-aligned lawmaker holding political office in Florida is Richie Floyd, a former electrical engineer and Pinellas County science instructor who narrowly won a city council seat in St. Petersburg in 2021, but has garnered no opponents for re-election this year. In his four-and-a-half-years in office, he's carved out a reputation as an advocate for tenant rights, improving public services, and fighting on working-class issues.

This Florida drag queen doubles as a marine animal conservationist

"Trusted climate information should not disappear when politics change," Lindsey said.

US Supreme Court upholds birthright citizenship, rejecting Trump order

The U.S. Supreme Court struck down President Donald Trump's attempt to redefine the constitutional right to birthright citizenship. In the decision, a majority of the justices upheld the country's long understanding of automatic citizenship by birth on American soil, regardless of the immigration status of a newborn's parents. The majority opinion, written by Chief Justice John G. Roberts, Jr., found the president's executive order violated the 14th Amendment of the U.S. Constitution. "Citizenship, then and now, was the right to have rights — to freely participate in our political community," he wrote. "The Framers of the Fourteenth Amendment extended that promise to 'every free-born person in this land.' We keep that promise today."

While my rights gently weep in the free State of Florida

Women's liberation has taken a huge hit in the state of Florida, and other freedoms—along with the right to vote—are now falling with it.

In June 2022, *Roe v. Wade* was overturned, ending the 49-year constitutional right to abortion, and leaving it up to the states to decide a woman's right to autonomy over her body. In the "Free" state of Florida, as DeSantis has so proclaimed on the signs as you enter the state on the highway, the "Heartbeat Protection Act" (SB 300) prohibits abortions after 6 weeks of pregnancy, basically banning abortion early in the first trimester.

Amendment 4 was a right-to-abortion initiative in 2024, which was defeated due to the state requiring a 60 percent vote for approval, with the amendment procuring 57 percent. So much for women having rights over their own bodies. We now have fewer rights than our mothers had in the 1970s.

Now in 2026, it gets worse. Florida legislators have been busy concocting bills reminiscent of Orwell's "1984." A couple horrid bills have passed. A third, thankfully, died before it could come to fruition.

HB 1471, or the "Outlawing Activism" bill, was signed into law by DeSantis on April 6. ACLU Florida, Equality Florida, Florida Immigrant Coalition and other organizations strongly opposed this bill, urging calls from the public to ask their representatives to vote "No."

Unfortunately, most of our Republican state reps are so busy brown-nosing DeSantis that they no longer seem to care what their constituents think, and they voted along party lines. It is screaming McCarthyism and allows the state to label people and groups they don't like or don't agree with as domestic terrorists without due process, using the term to censor Floridians who disagree with the government.

It gravely infringes on our First Amendment rights and is an unconstitutional attack, which serves to intimidate, rather than protect, the public. Its vague definitions of "domestic terrorist organizations" can be used to silence advocacy groups, student organizations and faith groups. It can be used to target legitimate, peaceful activism that differs from the governor's point of view. Students who "support or promote designated terrorist organiza-

tions" can be expelled and universities that have ties to these organizations can lose state funding.

On April 1, Gov. Ron DeSantis signed the Elections bill (HB 991), also known as the Florida SAVE Act. The law takes effect on Jan. 1. The law requires people who need to update or change their voter registration and those voting for the first time to prove their citizenship. DeSantis claims this law will protect voter registration. In reality, it is unfounded propaganda and not supported by any evidence that there's rampant, wide-spread non-citizen voting.

To prove citizenship you will need one of the following: Birth Certificate, U.S. Passport, Certificate of Naturalization or Certificate of Citizenship, or Consular Report of Birth Abroad. A birth certificate is the easiest way and if you were born in Florida, you can order a certified Florida birth certificate through Vital Records Online. If you were born in another state, you'll need to request the certificate from that state's vital records office. The Florida Real ID driver's license does not provide proof of citizenship.

For current registered voters, if state or federal databases can't verify your citizenship, you may be required to submit additional documentation to remain registered. If records are missing or inconclusive, you may receive a notice requesting proof. Having a certified birth certificate or valid passport ready protects you in either case. But, that's IF your name matches.

This bill is an outright attack on women, because as tradition has it, in heterosexual marriage it's the woman who changes her name when she gets married. If your current legal name differs from the name on your birth certificate — due to marriage, divorce, or a court-ordered name change — you will likely need to provide a certified marriage certificate, divorce certificate, or court order connecting your birth name to your current legal name.

In reality, this is just another way for DeSantis and the far right to disenfranchise millions of voters by requiring documents from the government that cost money, and will significantly decrease the number of people in the state who can vote. Florida doesn't have a good public transportation system, so the requirement to get to the office and obtain all the documents and then prove your citizenship is a deliberate attempt to limit the people's voice in

Florida. This will affect married people who have changed their names, people of low income status, minorities, the elderly and people with disabilities.

HB 945/ SB 1712 was an Orwellian "Mass Surveillance" bill which also challenged Free Speech and First Amendment rights. This bill would have created a powerful new state intelligence unit with authority to surveil and conduct "direct action missions" against individuals and organization based on their views or opinions. The bill's definition of who could be targeted was so broad it included journalists, activists, non-profit leaders, political organizers, and everyday Floridians exercising their first amendment rights.

The bill was found favorable in three House committees — Government Operations Subcommittee, Judiciary and Budget — but by the grace of the universe DIED in the State Affairs committee. Even though this bill is no more, it's important to be aware of what legislators are trying to pass.

Next time you drive by a "Welcome to the Free State of Florida" sign on the state line, really question how true that statement is. Maybe if you're a white, straight, rich male. The rest of us just continue to fight while our rights are stolen from us. We must be aware and cognizant of different bills that Florida legislators are attempting to pass and how they affect our rights, and fight them tooth and nail.

Oral History Program

History and the people who make it: Judge Charles Burton



This interview is from a continuing series of transcript excerpts from the collection of the Samuel Proctor Oral History Program at the University of Florida.

Julian Pleasants [P] interviewed Judge Charles Burton [B] on April 5, 2001. Burton recounts his firsthand experience serving on the Palm Beach County canvassing board during the disputed 2000 presidential election between George Bush and Al Gore, describing the manual recounts, legal battles, and extraordinary political pressures that surrounded Florida's vote. Reflecting on the controversy months later, he argues that election officials at every level should have remained nonpartisan, criticizes both political parties for injecting politics into the recount process, and calls for clearer statewide standards, improved voting technology, and greater voter education to restore confidence in elections.

P: How did you come to be a member of the Palm Beach County canvassing board?

B: I was appointed to the bench in May of 2000 by Governor Jeb Bush. Sometime around August, I received a call from our chief judge's office asking whether I would serve on the canvassing board, which oversees elections. I was told the function of a canvassing board was mostly supervisory, making sure the voting equipment was working properly. I had no idea then what the following November would bring.

P: What were your responsibilities on Election Day?

B: Election Day was like any other day for me until about 4 p.m. We went to the Supervisor of Elections office, reviewed absentee ballots that had to be examined, checked signatures when necessary, and

made sure the voting equipment was functioning properly. After the polls closed, we ran the ballots through the counting machines, verified there were no errors, signed the paperwork, and expected to go home. That is what normally happens.

P: When did you realize this was going to be an extraordinary event?

B: It is funny because I had voted myself by absentee ballot the Friday before. When I got to the office that afternoon someone showed me the butterfly ballot and said, "Go vote for Gore. So I put in a ballot and punched out Gore and, what is the problem?" Well, people had been complaining they accidentally voted for Buchanan.

At first I probably did not pay much attention to it. As the evening went on, we realized it was a close election, but honestly, Gore was ahead in Palm Beach County. He had won Palm Beach County by over 100,000 votes, so I really was not thinking anything unusual was happening here.

Around 3:30 a.m. I went home, thinking Gore had carried Florida. I was awakened later that morning and told to come back because Bush had been declared the winner, then the result changed again, and now there was going to be a recount.

P: Describe how you organized the manual recount.

B: Under Florida law, if the margin is one-half of one percent, a candidate can request a manual recount. The machines separate ballots they cannot read into a "reject" pile. Those rejected ballots are examined by hand to determine whether the intent of the voter can be determined.

Palm Beach County was divided into precincts. Three precincts were selected by the Democratic Party, three by the Republican Party, and three by the canvassing board. We began counting those ballots while the county continued rerunning all ballots through the machines.

P: How accurate is a hand recount?

B: One thing the media demonstrated very clearly is that hand recounts are not very accurate. Different people can look at the same ballot and honestly disagree about whether a vote should count. If you hand the same stack of punch-card ballots to two people, you may not get the same result. The process is simply too subjec-

tive to produce absolute certainty.

P: Why did Theresa LePore choose the butterfly ballot? Did you have any input?

B: It was entirely her decision. Florida law gives the supervisor of elections responsibility for ballot design. The Division of Elections specifies what information must appear on the ballot, but the design itself is left to each county supervisor. It was not a canvassing-board function.

Theresa's primary concern was complying with the Americans with Disabilities Act. Because there were so many presidential candidates, the print would have been extremely small had everything appeared on one page. She believed splitting it across two pages would make the ballot easier to read. Unfortunately, what seemed like a good-faith effort created tremendous controversy.

P: How accurate are punch-card voting machines?

B: I certainly do not claim any expertise beyond what I learned during this election, but I do know this: technology alone is not the answer. My view is that voter education is every bit as important. Until people understand how to vote correctly, whether with punch cards or newer technology, we are always going to have problems.

P: During the recount there were conflicting opinions from the Division of Elections, the attorney general, and your own attorney. How did you deal with that?

B: We were trying to be nonpartisan. I was a judge sitting there trying to follow the law, and every day the legal advice seemed to change. The Division of Elections was saying one thing, the attorney general another, and our own attorney had concerns about both positions. Rather than rush into a decision, we asked the Division of Elections and the attorney general to give us guidance so we could proceed under the law.

P: At one point the canvassing board voted two to one to proceed with the recount, and you dissented.

B: I felt the motion was premature. My concern was not whether votes should be counted. My concern was that we should

first know what the law required. We were receiving conflicting legal opinions, and I believed we should resolve those questions before moving forward.

P: Did you think Secretary of State Katherine Harris and Attorney General Bob Butterworth acted objectively?

B: No. I believed both offices were acting in partisan ways. That was frustrating because the canvassing board was trying to do its job under tremendous public scrutiny while political officials were sending conflicting signals. Our responsibility was simply to conduct the recount according to Florida law.

P: Did you think Secretary Harris should have recused herself?

B: Looking back, she probably should have, and I think the attorney general should have as well. When public officials have such visible political affiliations, it becomes much harder for the public to believe that election decisions are being made impartially.

P: The Florida Supreme Court allowed the recount to continue. What was your reaction?

B: I believed the court sincerely wanted every legal vote counted. At the same time, the rules seemed to change as the process unfolded. One county was applying one standard, another county a different one. That troubled me because elections should be administered consistently.

P: Do you think the Gore campaign made a mistake by requesting recounts in only selected counties?

B: I do. If you are going to have a recount in a statewide election, it ought to be statewide. Otherwise, it creates the appearance that recounts are being requested only where one side believes it may gain votes. Whether or not that was the intent, appearances matter in elections.

P: So you believe statewide standards are essential?

B: Absolutely. One of the biggest lessons from this election is that voters throughout the state deserve to be treated under the same rules. If identical ballots are judged differently depending on the county, people naturally begin to question whether the system is fair.

P: How did the canvassing board decide what constituted a vote?

B: We tried to be as consistent as possible. Earlier opinions had suggested a “one-

corner” standard for punch-card ballots, and after consulting with the county attorney we continued applying that standard. We were not trying to invent new rules. We were trying to apply one rule consistently to every ballot that came before us.

P: Did the board work well together despite political differences?

B: Yes. We disagreed at times, but everyone understood that our responsibility was to administer the election fairly. We tried very hard to leave politics outside the room. As the recount continued, I think we developed mutual respect because everyone recognized how important it was for the public to have confidence in what we were doing.

P: What was it like working under such extraordinary pressure?

B: There were lawyers everywhere, observers challenging ballots, television cameras, and intense public attention. After a while you almost became numb to it. Our focus had to remain on the ballots in front of us. If we allowed ourselves to become distracted by the politics surrounding the recount, we could not do the job we had been asked to do.

P: What lessons have we as a country learned from this election?

B: I certainly hope we have learned that when people tell you to get out and vote, your vote really does count. This election proved that. What also struck me was how many eligible people never voted at all. That is a sad commentary. In an election this close, there were still millions of people who chose not to participate.

P: So improving elections is about more than new voting machines?

B: Absolutely. Better equipment is important, but people also need to understand how to vote. We need better voter education. We need people to register, people to participate, and people to have confidence that their vote will count.

Here in Palm Beach County there were problems, but people came out in tremendous numbers because they believed their vote mattered. People need to stay involved.

P: How has this election changed Palm Beach County?

B: Other than being the butt of jokes around the country, I think Palm Beach County has clearly found itself under a microscope. Looking back, I think what happened here was less about Palm Beach

County than about what can happen anywhere. Every state ought to look at what happened and ask what improvements can be made. I hope people learn from it instead of simply assigning blame.

P: How has the experience changed your own life?

B: Other than people recognizing me on the street, I think it reinforced my belief that public officials have to do their jobs without regard to politics. When you accept a responsibility like serving on a canvassing board, you have to follow the law as best you can and let the consequences fall where they may.

P: Theresa LePore became the focus of enormous criticism. Looking back, how do you feel about that?

B: I think Theresa has had a rough time. She was trying to make the ballot easier to read, particularly for older voters and people with disabilities. She clearly made a mistake, and she has admitted that, but I also think she was unfairly demonized. People make mistakes. That should not erase a lifetime of public service.

P: What lessons have we as a country learned from this election?

B: I certainly hope we have learned that when people tell you to get out and vote, your vote really does count. This election proved that.

What also struck me was how many eligible people never voted at all. That is a sad commentary. In an election this close, there were still millions of people who chose not to participate.

We need better voter education. We need people to register, people to participate, and people to have confidence that their vote will count. Democracy depends on it.

‘Universal Primary Contest’: What’s that? AKA, Why the August 18 election is a one-time chance

I received my vote by mail ballot and saw the words “Universal Primary Contest” on two choices on the ballot. I had no idea what that meant. So, I did some research and talked with people who know about these things. Let me share what I learned.

Florida has Universal Primary Contests under some circumstances. Per the Supervisor of Elections of Marion County, that means that if all the candidates for a given seat have the same party affiliation, thus there will be no opposition in the general election, all voters of all parties or voters with no party affiliation can vote for the candidates in the primary election.

Translating that into the Alachua County election, for the race of State Representative, District 21 (retiring Yvonne Hayes Hinson’s seat) and the County Commission, District 2 (retiring Marihelen Wheeler’s seat), all registered voters can vote. That’s because all the candidates are Democrats and there is no other party with a candidate. That situation makes those races Universal Primary Contests.

Here’s the clincher. The candidate who has the most votes for those seats, wins the seat. Those races will not be on the general election ballot. The winning candidate does not have to get over 50 percent of the vote. For each of those races, there are multiple candidates, so getting over 50 percent by any one candidate is unlikely. That’s part of the reason the Aug. 18 election is a one-time chance.

Additionally, there are a number of other races on the ballot that

will or could be decided by the vote from the Aug. 18 primary even though they are not Universal Primary Contests. Non-partisan races are County Judge Group 5, Gainesville Mayor, and School Board District 3. Since there are only two candidates in each race, one candidate winning over 50 percent of the vote is likely. Other races, School Board District 1, and Gainesville City Commission Districts 2 and 3, are non-partisan and could be decided by the August 18 election if one of the three candidates receives over 50 percent of the votes.

All elections at all levels of government are important, as we can see from the federal and state fiascos that beset us. In our daily lives, our vote for local leadership has much impact. I have been following the county commission race carefully. In my mind, with the state preemptions – taking over decisions that used to be made by local leaders, it is important for our leadership to know what choices have been taken away from us and what tools we have to preserve the values and culture of our unique Alachua County.

In addition, we have the looming Amendment 3 referendum on our November ballot that, if passed by 60 percent of Florida voters, will take away over \$50,000,000 of income from Alachua County in 2027. It would significantly reduce homestead property tax revenue and, by necessity, make the county and cities raise other taxes and fees to cover emergency services and some 250 other county programs, like veterans’ services and the animal shelter. We need the best, most experienced leadership we can get to discourage the passage of the referendum and to respond to it if it passes.

Bottom line: each of us needs to be an informed voter. Please see Donna Waller’s article on page 1 for candidate information sources. The Alachua County Democratic Party hosted a series of forums for each race. They are posted at: tinyurl.com/iguana2534. There is a whole lot of stuff going on that hits us in the gut but we have little control. We have more control in our local elections where we can meet candidates, read about them, watch them on videos and choose them for their qualifications and their plans for our community that reflect our values and priorities. Let’s vote by August 18! 🐊

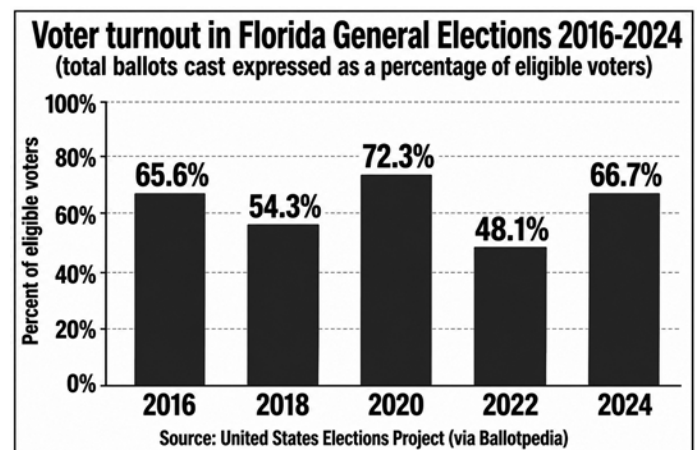

Appeals for the Eleventh Circuit in the decision. “Forcing an official government line—in a college classroom of all places—is exactly the ‘pall of orthodoxy’ that the First Amendment will not tolerate.”

In September 2022, the FIRE filed a lawsuit challenging Florida’s “Individual Freedom” law (dubbed the “Stop WOKE Act” by its proponents). FIRE’s lawsuit—on behalf of a professor, a student, and a student group—argued that the higher education provisions of the act unconstitutionally chill free expression and mandate faculty censorship on the state’s college campuses. In today’s ruling, a majority of the Eleventh Circuit panel agreed.

“Today’s important decision means that college remains a place where professors and students are allowed to debate controversial topics—even if politicians disagree with them,” said FIRE senior attorney Greg H. Greubel. “Today’s ruling makes clear something we’ve known for a long time: Governments cannot censor their way to freedom.”

The ruling by the Eleventh Circuit (which covers Florida, Alabama, and Georgia) is a crucial victory for academic freedom and free inquiry on our public campuses. The court joins the Second, Fourth, Fifth, Sixth, Seventh, and Ninth Circuits in holding that the First Amendment protects public university faculty’s academic freedom when they engage in teaching and scholarship. No appellate court has come to a different conclusion.

“As a professor, I shouldn’t have to choose between teaching to the best of my ability or facing punishment,” said Professor Adriana Novoa, who teaches Latin American history at the University of South Florida. “This decision is such a relief to professors who care about their students and want them to become well-rounded and informed. It will allow me and countless other professors to teach our classes without government interference.”

The appeals court held that Florida’s “Stop WOKE Act” violates the First Amendment because it “bars Florida’s educators from promoting or endorsing” disfavored ideas about “race, color, sex, and national origin” while allowing criticism of those same ideas. As the court explained, the law targets eight concepts, including whether a person is inherently biased based on race or sex, whether privilege or oppression is determined by race or sex, and whether virtues such as “merit, excellence, hard work, fairness, neutrality, objectivity, and racial colorblindness” are racist.

The court emphasized that “the First Amendment trusts students to figure it out for themselves” and rejected Florida’s claim that it may control professors’ speech because it pays their salaries. “Florida’s restrictions are, as the State admits, an attempt to force uniformity of thought on students by curtailing the free exchange of ideas in universities—the very environments traditionally regarded as laboratories for expression and truth seeking,” wrote Judge Grant.

The Eleventh Circuit’s ruling means that the district court’s November 2022 injunction halting enforcement of key parts of the act in Florida’s public universities remains in place. In its injunction, the district court called the act “positively dystopian.”

FIRE represents Professor Novoa, former student Sam Recheck, and the First Amendment Forum student organization in the suit, with Florida attorney and FIRE Legal Network member Gary Edinger serving as local counsel.

FIRE’s challenge to the Stop WOKE Act was heard alongside a related challenge filed by the ACLU, ACLU of Florida, and NAACP Legal Defense Fund.

Amicus support from across the ideological spectrum included briefs from the Academic Freedom Alliance, American Association of University Professors, Cato Institute, First Amendment Lawyers Association, Profs. Amna Khalid and Jeffrey Aaron Snyder, LatinoJustice, Learning for Justice and the Florida Freedom to Read Project, The New Press, policing scholars and organizations led by Law Enforcement Action Partnership, the National Education Association, United Faculty of Florida, National Black Law Students Association, Stand for Freedom, and PEN America.

County Judge 5: Continuing the trend, two really good options here with Eric Atria and Abroncee Martin. Eric is active in the community as a musician, as a lawyer with 21 years of public defense work, teaching at the Law School, as well as performing a lot of Pro bono work. Abroncee has been a long time strong presence in the Public Defenders office and has a lot of support from within the workers there. We win either way but I will go with Eric, he's worked really hard for this.

School Board District 1: Hunter Miller against the DeSantis appointee Plavic. Hunter for sure.

School Board District 3: Sarah Rockwell has been doing a great job and should be re-elected.
